The Thursday Group Privacy Notice

The Thursday Group Membership Secretary will be the 'Controller' of the personal data you provide to us. Updates Editors and committee members may be 'Processors' of selected data required to undertake their roles and to organise events.

The Thursday Group only collects basic personal data about you which does not include any special types of information. The data we hold include your name, address, email address, and phone number(s).

Why we need your data?

We need to know your basic personal data in order to be able to communicate with you and where necessary to provide you with updates and information. The group's core purpose is to organise events for the benefit of members and very much needs the members themselves to lead and organise activities. This will sometimes require the organising member to share email addresses and telephone numbers in circulation lists and proactively communicate to other members.

We will not collect any personal data from you we do not need in order to provide and oversee this service to you. We only store and process your personal data on the basis of our legitimate interests.

What we do with your data?

All the personal data we hold on you is processed in the UK. No third parties have access to your personal data unless the law allows them to do so.

We have a Data Protection regime in place to oversee the effective and secure processing of your personal data. More information on this is available on request.

How long we keep your data?

Your information will be kept by us until you notify us that you no longer wish to receive any communication or information from us or you leave the group.

What are your rights?

If at any point you believe the information we process on you is incorrect you can request to see this information and have it corrected or deleted.

If you wish to raise a complaint on how we have handled your personal data, you can contact us to have the matter investigated by emailing tgroup555@gmail.com.

If you are not satisfied with our response or believe we are not processing your personal data in accordance with the law you can complain to the Information Commissioner's Office <https://ico.org.uk/>.
